the agreement on the transfer of business interests according to which the company ADEPTO d.o.o. transferred to the company STIPIĆ GRUPA d.o.o. 10 percent of the interest in the company CENTAR BUNDEK, limited liability company for civil engineering, with the head office in Zagreb, Kninski trg 14, registered with the court register of the Commercial Court in Zagreb under the registration No. (MBS) 080508330, PIN (OIB) 33746159577 for the amount of HRK 9,356,800.00. Following this transaction, the new ownership structure of the company CENTAR BUNDEK d.o.o. is as follows: ADEPTO d.o.o. (100% owned by INSTITUT IGH, d.d.) 40%, KONSTRUKTOR-INŽENJERING d.d., 40%, and STIPIĆ GRUPA d.o.o., 20%.
