On 08th November 2016, the Commercial Court in Zadar passed the Decision on an entry of an increase in share capital of the company Ilirija d.d. (hereinafter referred to as: Company or Issuer) into the court registry which was received by the Company on 09th November 2016.

According to the aforementioned Decision, the Company's share capital increased from HRK 159,085,880.00 by the amount of HRK 15,892,000.00 to the amount of HRK 174,977,880.00 by issuing 27,400 New Ordinary Bearer Shares. Following the increase in the share capital, the share capital of the Company amounts to HRK 174,977,880.00 and is divided into 301,686 ordinary bearer shares with a single nominal amount of HRK 580.00 each.
