"Mr. Goran Medić from Zadar, residing at Ivo Senjanin 12/c, Tax No. OIB: 54770742757 was unanimously elected as a <u>president of</u> the Supervisory Board of the Company, who performed this duty in the previous term of office as well.

The same Notification in the Croatian language is correct and is not subject to correction.
