Pursuant to Article 459(3) of the Capital Market Act and Article 17 of Regulation (EU) No 596/2014 on market abuse, the company JADRAN – GALENSKI LABORATORIJ d.d. (hereinafter referred to as JGL d.d., the "Company") hereby discloses that the Company's Board of Directors has approved issuing bonds in order to refinance the existing bond issue in the amount of HRK 130 million; however, the final amount of the new bond issue will be determined by the Issuer (hereinafter referred to as "Transaction").

The decision has been made by taking into consideration the investment cycle planned for the coming period and the maturity of the existing bond in 2020, as well as current market conditions. The Company has hired consultants for the purpose of support – the bank Privredna banka Zagreb d.d. as the Issuing Agent, and the Tus i Andrijanić d.o.o. law firm from Zagreb, acting as legal counsel and Administrative Agent.

In the event that the Transaction is carried out, JGL d.d. shall disclose the information in a timely manner, in compliance with its legal obligations.
