We hereby inform you that pursuant to the Act on the Management and Disposal of Assets owned by the Republic of Croatia (Official Gazette nos. 94/2013, 18/2016 and 89/2017 - the Decision and ruling of the Constitutional Court of the Republic of Croatia) and the Regulation on the manner of sale of stocks and business shares (Official Gazette nos. 129/2013 and 66/2014), CERP, as legal representative of the Republic of Croatia and on its own behalf, on 6 April 2018, and PBZ CROATIA OSIGURANJE d.d. for compulsory pension funds management, Zagreb, Radnička cesta 44, company registration number (MBS): 080406496; company identification number (OIB): 20455535575, on its own behalf and for the account of PBZ CROATIA OSIGURANJE Compulsory Pension Fund - category A, company identification number (OIB): 94002620905, on its own behalf and for the account of PBZ CROATIA OSIGURANJE Compulsory Pension Fund - Category B, company identification number (OIB): 99318944138, and ERSTE d.o.o. - company for voluntary and compulsory pension funds management, Zagreb, Ivana Lučića 2/a, company identification number (MBS): 080407542, OIB:49659289650, on its own behalf and for the account of ERSTE PLAVI COMPULSORY PENSION FUND CATEGORY B. company identification number (OIB): 37688683890, on its own behalf and for the account of ERSTE PLAVI COMPULSORY PENSION FUND CATEGORY A, company identification number (OIB): 29597039090 on its own behalf and for the account of Erste Plavi Expert - Voluntary Pension Fund, company identification number (OIB): 21938195883, have concluded the Agreement on the sale and transfer of shares of the company Jadran d.d., number: 3145662/90000.

Concerning the foregoing, on 6 April 2018 the Republic of Croatia has released a total of 28,873,831 of the Issuer's stocks, mark JDRN-R-B, each in nominal value of HRK 10.00, representing 58.77% of the total voting rights of the Issuer, and thus fell below the threshold of 10.00% of the Issuer's voting rights, and CERP has released a total of 5,880,937 of the Issuer's stocks, mark JDRN-R-B, each in nominal value of HRK 10.00, representing 11.97% of the total voting rights of the Issuer, and thereby fell below the threshold of 5.00% of the voting rights of the Issuer.

After the release of stocks, on 6 April 2018, the Republic of Croatia, represented by CERP, has 2,492,020 stocks of the Issuer, representing 5.07% of the total voting rights in the Issuer, and CERP no longer has stocks of the Issuer.

CERP shall deliver this notification to the Croatian Financial Services Supervisory Agency.
