Pursuant to Article 482 of the Capital Market Act (OG 65/2018), the Restructuring and Sale Centre, Croatian tax number (OIB): 38083028711, Ivana Lučića 6, Zagreb (hereinafter: CERP), as a legal representative of the Republic of Croatia, Croatian tax number (OIB): 52634238587, represented by its Director Milan Plećaš with residence in Zagreb, on PIČMANOVA ULICA 1, hereby fulfils its legal obligation to notify JADRAN d.d., court registration number (MBS): 0400000817, Croatian tax number (OIB): 56994999963, Crikvenica, Bana Jelačića 16 (hereinafter: the Issuer) on the reduction in its number of voting rights.

We hereby notify you that following the Decision on Share Capital Increase of the General Shareholders Meeting of the Issuer of 24<sup>th</sup> August, 2018 the share capital increase has been recorded in the registry of the Commercial Court in Rijeka with a resolution recoded under file number Tt-18/5790-2 of 4<sup>th</sup> October, 2018 and after the Issuer's share capital increase was recorded, the Republic of Croatia's percentage in the voting rights fell under 5%.

After the above-mentioned share capital increase, as of 18<sup>th</sup> October, 2018 the Republic of Croatia represented by CERP has 830.673 Issuer's shares, which is 2.97% of the total number of voting rights.
