NOTIFICATION ABOUT THE CEREMONIAL SIGNING OF THE CONTRACT FOR THE CONSTRUCTION OF THE PORT HINTERLAND WAREHOUSE ŠKRLJEVO IN THE FREE ZONE OF THE PORT OF RIJEKA - ŠKRLJEVO AND THE CONTRACT FOR THE CONSTRUCTION SUPERVISION SERVICES IN RELATION TO THE CONSTRUCTION OF THE PORT HINTERLAND WAREHOUSE ŠKRLJEVO IN THE FREE ZONE OF THE PORT OF RIJEKA - ŠKRLJEVO

Pursuant to Article 459 of the Capital Market Act, we hereby notify you that the Contract for the construction of the port hinterland warehouse Škrljevo in the free zone of the Port of Rijeka - Škrljevo and the Contract for the construction supervision services in relation to the construction of the port hinterland warehouse Škrljevo in the free zone of the Port of Rijeka – Škrljevo have been signed on Tuesday, 19th July 2016 in Rijeka.

The Contract for the construction of the port hinterland warehouse Škrljevo in the free zone of the Port of Rijeka – Škrljevo was signed by the members of the Company Management of the Port of Rijeka, Vedran Devčić, President of the Company Management, Linda Sciucca and Nenad Janjić, members of the Company Management, and the contractor of construction works, joint bidders GP Krk j.s.c. (Krk), VIADUKT j.s.c. (Zagreb) and G.P.P. Mikić Ltd. (Omišalj). The contract has the value of 218.86 million Kuna, the agreed deadline for the completion of construction works is 14.5 months and it encompasses the reconstruction and modernization of the existing warehouses and canopies, the construction of new warehouses and canopies, the reconstruction and the modernization of the existing and the construction of new infrastructural capacities (transport and manipulative surfaces, industrial tracks, energy infrastructure, energy substation, waterworks and sewerage system etc.).

The Contract for the construction supervision services in relation to the construction of the port hinterland warehouse Škrljevo in the free zone of the Port of Rijeka – Škrljevo was signed with the company *INVESTINŽENJERING ltd.* from Zagreb.

The investment project for modernization and expansion of the hinterland terminal Škrljevo was initiated with the goal to enlarge the port capacities for container traffic, including the capacities for all ancillary activities in relation to container manipulation, from storing empty containers to stuffing and stripping, container maintenance etc., and the capacities for storing general and bulk cargo. The Škrljevo Project will enable the hinterland terminal to develop the all-inclusive operative support to the existing Brajdica container terminal and the future new container terminal on the Zagreb pier, as well as increase the capacities of the Port of Rijeka in relation to the transshipment of general and bulk cargo..
