The Company's General Meeting adopted the decision to entirely replace the Company Statute of 07/08/2011 with the new Statute dated 05/30/2014 and filed with this Court's Register of Documents.

Changes to the share capital:

By virtue of the Company Board of Directors' decision of 05/27/2014, and by investing rights through the conversion of a part of pre-bankruptcy creditors' claims, the share capital has been increased as approved share capital, from the amount of HRK 28,200,700.00, by the amount of HRK 535,587,570.00, to the amount of HRK 563,788,270.00, through the issuance of 53,558,757 dematerialized ordinary registered shares, each having the nominal value of HRK 10.00.
