Re: Notice pursuant to Article 430 of the Capital Market Law - acquisition of own shares

Pursuant to the Capital Market Law,the Zagreb Stock Exchange Rules and Resolution on acquiring own shares by the Company adopted on 15<sup>th</sup> February 2016, PODRAVKA Inc., Ante Starčević 32, Koprivnica, PIN: 18928523252 (Company) announces the acquisition of 453 own shares, which is an amount of 0.006362% of share capital of the Company.
