**Re: Notice pursuant to Article 430 of the Capital Market Law
- acquisition of own shares - correction of previously published notice**

Pursuant to the Capital Market Law, the Zagreb Stock Exchange Rules and Resolution on acquiring own shares by the Company adopted on 15th February 2016, PODRAVKA Inc., Ante Starčević 32, Koprivnica, PIN: 18928523252 (Company) announces the acquisition of 790 own shares, which is an amount of 0.0110% of share capital of the Company.

After stated acquisition Company has 178,560 own shares, which represents 2.50% of share capital of the Company.

Shares have been acquired by trading at the Zagreb Stock Exchange as follows:

- on 19th February 2016 – 268 shares at an average price of HRK 314.85,
- on 22nd February 2016 – 9 shares at an average price of HRK 314.70,
- on 24th February 2016 – 254 shares at an average price of HRK 315.95 and
- on 25th February 2016 – 259 shares at an average price of HRK 315.00 per share.

The purpose of the acquisition is implementing the ESOP program and realization of the management and employees remuneration plan, compliant to the Company remuneration policy.
