On the same day the Company has assigned the above mentioned ordinary shares of the Company within the realisation of the Company share purchase option right of Mr. Zvonimir Mršić – President of the Management Board of the Company.

After mentioned acquisition and releasing of the shares, the number of the Company's own shares issued with voting rights remained unchanged.
