**Re: Notice pursuant to Article 430 of the Capital Market Law
- acquisition of own shares**

Pursuant to the Capital Market Law, the Stock Exchange Rules and Resolution on acquiring own shares by the Company adopted on 15th February 2016, PODRAVKA Inc., Ante Starčević 32, Koprivnica, PIN: 18928523252 (Company) announces the acquisition of 556 own shares, which is an amount of 0.0078 % of share capital of the Company.

After stated acquisition Company has 195,309 own shares, which represents 2.74 % of share capital of the Company.

Shares have been acquired by trading at the Zagreb Stock Exchange as follows:

- on 25th August 2016 - 16 shares at an average price of HRK 359.99,
- on 26th August 2016 - 280 shares at an average price of HRK 366.00 and
- on 29th August 2016 - 260 shares at an average price of HRK 363.00 per share.

The purpose of the acquisition is implementing the ESOP program and realization of the management and employees remuneration plan, compliant to the Company remuneration policy.
