Mandatory and Voluntary Pension Funds management company informed the Issuer that on 31.08.2018. and 3.09.2018. it has acquired the shares of the Issuer, on behalf of Erste Closed-end Voluntary Pension Fund, Closed-end Voluntary Road Workers Pension Fund, Nestlé Closed-end Voluntary Pension Fund and Erste Plavi Mandatory Pension Fund Category A.

This Notice is provided due to the fact that Mr. Petar Vlaić, an insider on the Insider List of the Issuer – is the Member of the Supervisory Board of the Issuer – who also holds the position of the President of the Management Board of ERSTE d.o.o.
