SUBJECT: Changes in the percentage of voting rights

Based on Art. 482 of the Capital Market Act (NN 65/2018), Restructuring and Sale Center, NIN: 38083028711, Ivana Lučića 6, Zagreb (hereinafter: CERP) as a legal representative of the Republic of Croatia, NIN: 52634238587, represented by the director, Milan Plećaš, with residence in Zagreb, Pičmanova ulica 1,fulfills the legal obligation of being informed about the drop in voting rights in Petrokemija d.d., MBS: 08004355, NIN: 24503685008, Kutina, Aleja Vukovar 4, (hereinafter: the Issuer) by the Croatian Financial Services Supervisory Agency.

We inform you that, based on the Decision of the General Assembly of the Issuer from 7 July 2018 and 31 October 2018, the following was entered:

- -an increase of share capital in the register at the Commercial Court in Zagreb upon the Decision under the business number Tt-18/40058-2 dating from 2 November 2018,
- -a simple decrease in share capital in the register at the Commercial Court in Zagreb upon the Decision under the business number Tt-18/40062-2 dating from 5 November 2018,
- -an increase of share capital in the register at the Commercial Court in Zagreb upon the Decision under the business number Tt-18/40063-2 dating from 5 November 2018, and that, after the changes in the share capital of the Issuer, the Republic of Croatia has fallen under the threshold of 20% of voting rights.

After the mentioned changes in share capital, on 6 November 2018, the Republic of Croatia, represented by CERP, has 9.852.828 of the Issuer's shares, which represents 17.90% of total number of voting rights in the Issuer.
