Statute:

By the decision of the General Assembly of 9 July 2018, the Company's Statute of 11-10-2017, namely Article 7 (share capital), was amended.

In accordance with the Decision of the General Assembly on amendments of the Statute 1 of the Company, the Company's Statute was amended in Article 7 (share capital and number of shares).

Pursuant to the authority from the same Decision, the Supervisory Board determined the full text of the Statute. The full (consolidated) text of the Statute of 9-7-2018 has been submitted to the court and inserted in the collection of documents.

Changes in share capital

By the decision on the increase of the share capital in shares in rights and on issuance of shares with the exclusion of the priority rights of the shareholders of the company from 9-7-2018 the Company's share capital has been increased by issuing new non-materialized ordinary shares of the company by shares in rights and by entering receivables in the amount of HRK 450,000,000.00, thus the share capital from the previous HRK 42,903,930.00 is increased by the amount of HRK 450,000,000.00 to the amount of HRK 492,903,930.00.
