As attorneys of commercial companies SCAPUS limited liability company for business counseling seated in Zagreb, Miramarska cesta 24, OIB: 48823025014 (hereinafter: **SCAPUS d.o.o.**), Management board members: Lenka Veznikova and Edgar Prisender, and EPIC Goldscheider und Wurmböck Unternehmensberatungsgesellschaft m.b.H, seated in Austria, Vienna, Plösslgasse 8, entered into the register of Commercial Court in Vienna, OIB in the Republic of Croatia: 30046654289 (hereinafter: **EPIC GmbH**), Management Board members: Gustav Wurmböck, Peter Goldscheider and Franz Lanschützer hereby inform the issuer of shares company Valamar Riviera joint stock company for tourism, seated in Poreč, Stancija Kaligari 1 (hereinafter: Company) identification number of the business entity in court register (MBS): 040020883, OIB: 36201212847, Management Board: Franz Lanschützer - president of Management board and members of the Management board: Ivana Budin Arhanić, Marko Čižmek, Tihomir Nikolaš, Edi Černjul and Nikola Koncul and Croatian Agency for Supervision of Financial Services about the concluded transaction and the consequent transfer of shares between affiliated companies (EPIC GmbH is the sole member and owner of business shares in company SCAPUS d.o.o.) as follows:

Companies SCAPUS d.o.o. and EPIC GmbH have concluded the Agreement on sale of shares on the 19th of December 2014 with which they have agreed on the sale and transfer of Company shares from company SCAPUS d.o.o. to the company EPIC GmbH which comprise of 15.265.889 regular registered shares, without nominal value which represent 12,11% of total Company share capital and 12,15% of share capital reduced for the treasury shares.

Given that the company SCAPUS d.o.o. has held the stated number of Company shares, through the stated transaction it has fallen below the threshold of 10% and under the threshold of 5% of Company shares and does not own any more shares of the Company. Also, through this transaction the company EPIC GmbH has acquired the stated number of Company shares which have so far been indirectly in its indirect ownership through the sole membership in company SCAPUS d.o.o.

Therefore, the consequence of the transaction is the fall below the threshold of 10% and 5% of Company shares on the side of company SCAPUS d.o.o. After the concluded transaction company EPIC GmbH has in its direct ownership 54.267.510 of Company shares which represent 43,06% of total share capital of the Company and 43,21% of share capital reduced for the treasury shares.


