Subject: MT Velebit time charter employment secured

Tankerska Next Generation Inc. has secured employment for MT Velebit, the ice class product tanker for 12 months straight following the redelivery from her current charterer Stena Weco at the end of September. She will be chartered out to a prominent charterer at approximately US\$ 18,500 per day with usual market terms.

The agreed employment rate for MT Velebit outperforms model presumptions presented earlier this year in the rundown to the company's IPO in February. As well, the agreed hire rate will further strengthen the financial position of the company, and will enforce TNG on the path towards its initial plans. Achieved conditions are in line with the company's strategic concept that focuses on the efforts of management to secure a strong asset base and stable cash flow to ultimately support creating additional value for its shareholders.
