## **Notification on the transactions made by persons discharging managerial responsibilities with the Issuer**

Dear Sirs,

According to Article 19, Paragraph 3 of the Regulation (EU) No. 596/2014 on market abuse, ULJANIK PLOVIDBA d.d. with headquarters in Pula, Carrarina 6 (hereinafter referred to as: the Issuer) hereby notifies on the following transactions made by persons discharging managerial responsibilities with the Issuer:

- Acquisition of 19 shares of the Issuer with the following identification code: ULPL-R-A, ISIN: HRULPLRA0002, and the total nominal value of HRK 7,600.00, made by the Director of the Issuer, Mr. Dragutin Pavletić. The acquired shares represent 0.003% of the subscribed capital of the Issuer and give 0.003% of the votes at the Issuer's General Meeting. Following this acquisition the Director of the Issuer, Mr. Dragutin Pavletić, holds in total 36,394 shares of the Issuer with the total nominal value of HRK 14,557,600.00, representing 6.27% of the subscribed capital of the Issuer and 6.27% of the votes at the Issuer's General Meeting.
- Acquisition of 19 shares of the Issuer with the following identification code: ULPL-R-A, ISIN: HRULPLRA0002, and the total nominal value of HRK 7,600.00, made by the Assistant Director of the Issuer, Mr. Darko Šorc. The acquired shares represent 0.003% of the subscribed capital of the Issuer and give 0.003% of the votes at the Issuer's General Meeting. Following this acquisition the Assistant Director of the Issuer, Mr. Darko Šorc, holds in total 31,924 shares of the Issuer with the total nominal value of HRK 12,769,600.00, representing 5.50% of the subscribed capital of the Issuer and 5.50% of the votes at the Issuer's General Meeting.
