Notification on the transaction made by person discharging managerial responsibilities with the Issuer

Dear Sirs,

According to Article 19, Paragraph 3 of the Regulation (EU) No. 596/2014 on market abuse, ULJANIK PLOVIDBA d.d. with headquarters in Pula, Carrarina 6 (hereinafter referred to as: the Issuer) hereby notifies on the termination of fiduciary relationship previously entered into by the Assistant Director of the Issuer, Mr. Darko Šorc in relation to 1,500 shares of the Issuer with the following identification code: ULPL-R-A, ISIN: HRULPLRA0002, and the total nominal value of HRK 600,000.00.

The shares in respect of which the created fiduciary relationship has been terminated, represent 0.26% of the subscribed capital of the Issuer and give 0.26% of the votes at the Issuer's General Assembly.

Following the subject termination of fiduciary relationship, the Assistant Director of the Issuer, Mr. Darko Šorc holds in total 32,147 shares of the Issuer with the total nominal value of HRK 12,858,800.00, representing 5.54% of the subscribed capital of the Issuer and 5.54% of the votes at the Issuer's General Assembly.
