MORE THAN 10% OF SHARES OF THE ISSUER VARTEKS d.d.**

Pursuant to articles 428 and 441 of the Capital Market Act, we hereby inform shareholders and the public that the Management Board of the company Varteks d.d. received a notification from Nenad Bakić from Zagreb, Hrastovac 13A, that aforementioned acquired 7,507 shares with the code VART-R-1 on February 6, 2013, which constitutes 0.39% of all voting shares, whereby the total number of acquired shares went up to 10.076%. Given the total number of shares of the Issuer of 1,920,807, this constitutes ownership of 10.076% and equally as many voting rights.

The shares with the code VART-R-1 were acquired through a transaction concluded at the Zagreb Stock Exchange on February 6, 2013.

The threshold prescribed by the Capital Market Act was reached on February 6, 2013.

The notification on acquisition of more than 10% of Varteks d.d. shares is publicly available on the websites of the Zagreb Stock Exchange, HINA, Varteks d.d. and in the Official Register of Prescribed Information (HANFA).
